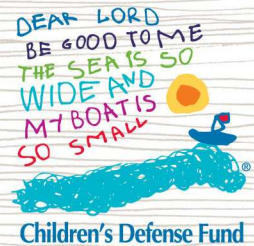

All Children Need Health Coverage that is Affordable, Comprehensive, and Simple.

Health Coverage for Indiana's Children:

- 111,000 children are uninsured (6.6% of all children). *
- 555,673 children are enrolled in Medicaid. **
- 124,954 children are enrolled in the Children's Health Insurance Program (CHIP). ***

How affordable is health coverage for Indiana's children? †

- CHIP eligibility is up to 250 percent of poverty (\$55,125 for a family of four).
- Medicaid eligibility is 200 percent of poverty (\$44,100) for children 0-1 and 150 percent of poverty (\$33,075) for children 1-19.

How simple are enrollment procedures in CHIP and Medicaid for Indiana's children?

- Simplification procedures:
 - No asset test
 - No face-to-face interview
 - Joint application
- Barriers that remain:
 - No 12-month continuous eligibility
 - No presumptive eligibility—which forces children to wait until their application is processed before they can see a doctor
 - No administrative verification of income—the state requires parents to provide proof of income before a child can get health coverage
 - 3 month waiting period
