2007 Minnesota Legislative Scorecard

Minnesota children can't vote or speak up for themselves. It is incumbent upon adults—policy makers and citizens alike—to ensure the health, safety and well-being of Minnesota's 1.2 million children.

We know that every dollar invested in our children comes back to our state many fold. That is why the Children's Defense Fund Action Council (CDF Action Council) produces an annual scorecard to inform citizens about how policy makers vote for and work on behalf of children.

The key votes used in the 2007 legislative scorecard were cast during a session marked by progress for children, but also one that left key investments and systemic changes on the table.

The scorecard highlights six key votes for representatives and five key votes for senators. The bills cover a range of issues important to Minnesota children, including health care coverage; early care and education; healthy environments; and minimum wage. Revenue-related bills that determine the budget parameters for legislators are also included.



Health care coverage is a key indicator of child well-being. That is why the Children's Health Security Act (CHSA), developed and pushed as a top priority by CDF Minnesota, is a centerpiece of this scorecard. The measure provides a solution to the current broken health care system. It would ensure that all children—including the 85,000 uninsured children and tens of thousands more who are underinsured—have access to health care coverage, no matter where their parents work or how much they earn.

During the session, the CHSA moved through the legislative process, passed the House of Representatives and, while it was not enacted, the effort behind it resulted in 35,000 uninsured children gaining access to health coverage.

The 2007 legislative session also brought progress in other key areas for children including making child care more affordable—so that hard working parents can enter and remain in the work force without worrying about the safety and well-being of their children—and increased investment in other early education programs.

Selecting votes for a scorecard is often difficult. Large omnibus bills contain hundreds of provisions, so a vote for or against a particular bill does not always tell the full story. In addition, many of this year's budget bills, including the important Health and Human Services bill, were vetoed by Governor Pawlenty. In order to reach an agreement between the legislature and governor, the amount of investment included in the final Health and Human Services (HHS) bill was significantly scaled back, and that meant fewer provisions to benefit children. For that reason, the CDF Action Council includes the vetoed HHS bill in its scorecard.

This scorecard is part of CDF Action Council's ongoing policy analysis and advocacy for children. **The scores should not be interpreted as an endorsement of—or opposition to—any legislator.** CDF Action Council's primary goal is to educate the public and provide a voice for children to ensure that they are a top priority as lawmakers debate hundreds of policies each year. This scorecard is a tool for child advocates to help lawmakers

understand the impact of their votes on Minnesota children and their families. CDF Action Council encourages you to use this document to let your lawmakers know what you think about their votes for Minnesota's youngest residents.

Legislative Children's Champions

CDF Action Council is proud to announce the third annual Legislative Children's Champions. Legislative Children's Champions are legislators who have gone above and beyond in their support for the well-being of Minnesota children. Why These Votes Are Important

Research has repeatedly shown that every dollar invested in children comes back many fold to our communities, our schools, our society, and our economy. With that in mind, CDF Action Council chose these votes to highlight in this scorecard.

Health Care (Senate Vote 3; House Votes 1, 2 & 4)

Health coverage is a key indicator of child well-being. Unfortunately, Minnesota has seen its children's uninsured rate rising since 2001. There are now an estimated 85,000 uninsured children in the state. Uninsured children are much less likely than children with insurance to get key preventive checkups, immunizations, and necessary medical care. Children with coverage have fewer long-term health problems, do better in class and miss less school. They also will perform better in the work force. Investing in children's health produces significant long-term savings in productivity to the health care system and contributes greatly to the overall health of the state.



Early Care and Education (Senate Votes 2, 3 & 4; House Votes 2, 4 & 5)

Research consistently shows that quality early childhood programs improve school readiness. A study published in August 2007 in the *Archives of Pediatric and Adolescent Medicine* supports previous research showing increased educational attainment for children who participated in high quality early care and education programs. The study also found benefits lasting into adulthood such as higher rates of health insurance and full-time

employment, and less need for public assistance. It also found lower rates of criminal behavior and depression.

Minimum Wage (Senate Vote 1)

Family economic security is central to children's ability to thrive. Children who live in poverty are more likely to suffer from poor health, to develop behavioral problems, to become teenage parents, and to fall behind in or drop out of school. A living wage is critical to economic security. A parent who works full-time earning the

current minimum wage earns just below \$12,800 annually, far below the federal poverty line for most families (e.g., the poverty line for a family of four is \$20,650).

Revenue (Senate Vote 2; House Vote 3)

Funding in areas that benefit children and their families, such as child care and health care, has been cut in recent budget sessions. Investing early in children has continuously produced positive long-term results. Increasing the resources available to invest in children's health care coverage, early care and education, and other areas that benefit children and their families is important to Minnesota's future.

Clean Air—Freedom to Breathe Act (Senate Vote 5, House Vote 6)

Secondhand smoke is the leading cause of preventable death in the United States. Infants and young children are especially susceptible as their lungs are still developing. In addition, pregnant women who are exposed to secondhand smoke are more likely to have lower birth weight babies.

2007 Senate Votes

Vote 1: Minimum Wage Increase



SF 875, authored by Senator Ellen Anderson, would increase the minimum wage required to be paid by large employers from \$6.15 per hour to \$6.75 per hour in 2007 and \$7.75 per hour in 2008. The minimum wage required to be paid by small employers would increase from \$5.25 per hour to \$5.75 per hour in 2007 and \$6.75 per hour in 2008. The legislation would also require annual inflation increases for the minimum wage and consumer protections. SF 875 *passed* on the Senate floor 40 to 23 (SF 875 was not enacted into law; only the Senate voted on the minimum wage bill in 2007). *Senate Journal*, page 2459, April 23, 2007.

Vote 2: Early Education Funding & Revenue Increase



SF 1611, authored by Senator Leroy Stumpf, established a prekindergarten education scholarship to increase access to quality early childhood settings for 3- and 4-year-olds. The scholarships, intended to improve school readiness, would be awarded based on income. The funding mechanism, also included in the bill, would be revenue generated from adding an additional income tax bracket. This legislation also provided funding increases for K-12 and higher education. The bill *passed* on the Senate floor 35 to 29 (provisions of the scholarships were enacted as part of the final Health and Human Services bill, the additional tax bracket was not enacted into law). *Senate Journal*, page 1927, March 31, 2007.

Vote 3: Health and Human Services Conference Committee Report



SF 2171, authored by Senator Linda Berglin and Representative Thomas Huntley, is the agreement reached between the House and Senate by the Health and Human Services Conference Committee. This bill included provisions of the Children's Health Security Act, which would significantly increase access to health care coverage for children by making coverage more affordable and removing cumbersome eligibility rules and administrative barriers. The legislation also included funding for early care and education including reduced parent co-payments for the Child Care Assistance Program (CCAP), new funding for a pilot project to increase access to quality care for CCAP families and new funding for home visiting targeted at increasing school readiness for high-risk children. The bill also included numerous other provisions that benefit children and families such as funding for crisis nurseries and food shelves as well as provisions that eased food support reporting requirements. The bill *passed* 47 to 19. *Senate Journal*, page 3710, May 7, 2007.

SF 2171 was vetoed by Governor Pawlenty on May 8, 2007. *The final HHS bill, with reduced spending, includes fewer provisions to increase access to and affordability of health care coverage for children and no funding increase for crisis nurseries and food shelves; the early care and education provisions and eased food support reporting remained in the final legislation.*

Vote 4: Final E-12 Education Funding



HF 2245, authored by Senator Tarryl Clark and Representative Mindy Greiling, includes increased funding for early education including Head Start, Early Childhood Family Education and School Readiness, restoring each of the programs to funding levels prior to budget cuts in 2003. The bill *passed* 51 to 15. *Senate Journal*, page 6035, May 21, 2007.

Vote 5: Freedom to Breathe



SF 238, authored by Senator Kathy Sheran and Representative Thomas Huntley, will eliminate the hazards of secondhand smoke in most enclosed spaces by prohibiting smoking in essentially all indoor public places, places of employment, and public transportation beginning October 1, 2007. The bill *passed* 43 to 21. *Senate Journal*, page 3954, May 11, 2007.

2007 House Votes

Vote 1: Children's Health Security Act Amendment



The Children's Health Security Act, which was included in the House Health and Human Services Omnibus bill (SF 2171), would ensure all children have access to quality, affordable and comprehensive health care coverage.

Amendment SF2171-A62 would have removed the Children's Health Security Act from SF 2171 and used the money allocated for the Children's Health Security Act to provide health care coverage for only 13,000 children, utilizing the remainder of the funds to eliminate a generic drug dispensing fee. While the broken health care system and rising costs – including prescription drugs – need to be addressed, taking money intended for children's coverage to address other health care issues is not a solution. The amendment *failed* 44 to 86. *House Journal*, page 4247, April 20, 2007.

CDF Action Council Position: **Oppose**

Vote 2: Health and Human Services Funding



SF 2171, the House Omnibus Health and Human Services bill, authored by Representative Thomas Huntley, included the Children's Health Security Act, which would ensure all children have access to quality, affordable

health care coverage as well as increased funding for the Child Care Assistance Program to increase access to and affordability of child care for low-income working families. The bill *passed* 86 to 45 (increased child care funding and provisions of the Children's Health Security Act were included in the final Health and Human Services bill). *House Journal*, page 4315, April 20, 2007.

Vote 3: Omnibus Tax Bill



HF 2362, the House omnibus tax bill authored by Representative David Dill, would have generated additional revenue for the state, by adding an additional income tax bracket. The bill *passed* 74 to 59 (the additional income tax bracket was not enacted into law). *House Journal*, page 4843, April 27, 2007.

Vote 4: Health and Human Services Conference Committee Report



SF 2171, authored by Senator Linda Berglin and Representative Thomas Huntley, is the agreement reached between the House and Senate by the Health and Human Services Conference Committee. This bill included

provisions of the Children's Health Security Act, which would significantly increase access to health care coverage for children by making coverage more affordable and removing cumbersome eligibility rules and administrative barriers. The legislation also included funding for early care and education including reduced parent co-payments for the Child Care Assistance Program (CCAP), new funding for a pilot project to increase access to quality care for CCAP families and new funding for home visiting targeted at increasing school readiness for high-risk children. The bill also included numerous other provisions that benefit children and families such as funding for crisis nurseries and food shelves as well as provisions that eased food support reporting requirements. The bill *passed* 82 to 44. *House Journal*, page 6112, May 7, 2007.

Vote 5: Final E-12 Education Funding



HF 2245, authored by Senator Tarryl Clark and Representative Mindy Greiling, includes increased funding for early education including Head Start, Early Childhood Family Education and School Readiness, restoring each of the programs to funding levels prior to budget cuts in 2003. The bill *passed* 94 to 36. *House Journal*, page 7557, May 21, 2007.

CDF Action Council Position: **Support**

Vote 6: Freedom to Breathe



SF 238, authored by Senator Kathy Sheran and Representative Thomas Huntley, will eliminate the hazards of secondhand smoke in most enclosed spaces by prohibiting smoking in essentially all indoor public places, places of employment, and public transportation beginning October 1, 2007. The bill *passed* 81 to 48. *House Journal*, page 6581, May 11, 2007.

The CDF Action Council is pleased to announce the 2007 Legislative Children’s Champions. Those chosen as Children’s Champions voted consistently for investments in children and supported all efforts to ensure every Minnesota child has access to health care coverage.

Because health coverage is essential to children’s ability to grow up healthy and thrive, CDF Minnesota’s Children’s Health Security Act (CHSA) is a key component of this year’s scorecard.

The Champions not only had a 100% voting record on key votes for children in 2007, but they also were co-authors of the CHSA (HF1-Thissen, SF 15 – Prettner Solon), and voted against all attempts to weaken or kill the measure.

During House floor debate of the House Health and Human Services Omnibus bill, several amendments were offered to strip the CHSA from the bill and use the allocated funds to fund other health care budget items. While the health care system is broken with several areas competing for limited funds, taking money allocated to ensure all children have health care coverage and putting it toward another health care need is not a solution. Voting against all amendments offered to remove



the CHSA was one of the three criteria necessary to be a Children’s Champion.

Contact your senator and tell him or her how important it is to ensure all children have access to quality, affordable health care coverage and urge your senator to support the Children’s Health Security Act.

If your representative is a Champion, thank him or her for unwavering support for children. If your representative is not a Champion, contact them and let them know how important investment in children is to the future of Minnesota, its families, its communities, and its economy.
