## A State Fact Sheet for Grandparents and Other Relatives Raising Children

**Alaska**  
October 2007

The AARP Foundation, The Brookdale Foundation Group, Children's Defense Fund, Casey Family Programs, Child Welfare League of America, and Generations United have partnered to produce fact sheets for grandparents and other relatives raising children that include state-specific data, programs, and public policies. ### In Alaska....

- 8,188 children live in grandparent-headed households (4.3% of all the children in the state). There are another 2,620 children living in households headed by other relatives (1.4% of all the children in the state). Of the children living in households headed by grandparents or other relatives in Alaska, 5,110 are living there without either parent present.
- 5,419 grandparents report they are responsible for their grandchildren living with them (1,719 in Anchorage): 4% of these grandparents are African American; 2% are Hispanic/Latino; 43% are American Indian or Alaskan Native; 4% are Asian; 2% are Native Hawaiian or Other Pacific Islander and 41% are White. 34% of these grandparents live in households without the children's parents present. 67.4% are under the age of 60; 11.5% live in poverty.

### Services Offered:

- Respite care for grandparents 55 and over
- Winter and summer camps for children
- Support group meetings monthly in Anchorage, Mat-Su Valley; more locations expected
- Assistance in establishing local support groups
- Counseling in person in Anchorage, by phone statewide

- Kinship Caregiver Resource Guide

## Children in Foster Care

State child welfare agencies sometimes place children in foster care with grandparents or other relatives. Most state agencies call these placements “kinship care.”

## Numbers

- 1,874 children in out-of-home placements under the supervision of the Alaska Office of Children’s Services (OCS) as of January 2006.
- 588 of these children were placed with relatives.
- 159 children were on trial home visits with 10 children in pre-adoptive homes with relatives.

## Preferences

- Alaska law requires that kinship care be considered first when an out-of-home placement is sought for an abused or neglected child.

## Kinship care licensing

- No separate licensing for kinship foster parents.
- Same licensing standards and training requirements as non-kin foster parents.
- Same foster care payment rate.
- Some training opportunities for non-licensed relative caregivers.

## Subsidized guardianship

- Alaska program provides subsidies to kin and non-kin guardians of children who are in state custody at the time guardianship plan is written.
- Subsidy may be awarded if recommended by the OCS Permanency Planning Conference Team, family has approved guardianship study and child meets other criteria.

## Public Benefits

Children are often eligible for state and federal benefits even if their caregivers do not have legal guardianship or custody.

## Financial Assistance

- Cash assistance may be available to children and their relative caregivers through the Alaska Temporary Assistance Program (ATAP).
