## A State Fact Sheet for Grandparents and Other Relatives Raising Children

### In Idaho....

- 13,636 children live in grandparent-headed households (3.7% of all the children in the state). There are another 4,128 children living in households headed by other relatives (1.1% of all the children in the state). Of the children living in households headed by grandparents or other relatives in Idaho, 7,087 are living there without either parent present.
- 8,110 grandparents report they are responsible for their grandchildren living with them (717 in Boise): .2% of these grandparents are African American; 12% are Hispanic/Latino; 1% are Asian; 4% are American Indian or Alaskan Native; 70% are White. 43% of these grandparents live in households without the children's parents present. 72% are under the age of 60; 14% live in poverty.

## Children in Foster Care

State child welfare agencies sometimes place children in foster care with grandparents or other relatives. Most state agencies call these placements “kinship care.”

### Numbers – State Fiscal Year 2007

- 3,241 children in out-of-home placements under the supervision of the Idaho Department of Health and Welfare
- 14-15% of these children were placed with relatives.

### Preferences

- State policy requires that placement priority be given to relatives or immediate family, next- to-extended family and then non-family members with a significant established relationship with a child.
- Same licensing standards, training requirements and payment rates as non-kin foster parents.

### Subsidized guardianship

- Idaho’s Department of Health and Welfare provides guardianship assistance benefits to children under the care of the Department whose parents have had their parental rights terminated and there is documentation of efforts to place the children for adoption.
- Guardianship Assistance pays for one-time costs to finalize the guardianship and related benefits (Medicaid) plus a negotiated monthly cash payment that cannot exceed the amount the child was receiving in a foster family.

### Public Benefits

Children are often eligible for state and federal benefits even if their caregivers do not have legal guardianship or custody.

## State Laws

*Laws change and are subject to different interpretations. These general descriptions are not intended as legal advice in any particular situation.*

## Medical Consent

### Idaho Code Ann. § 39-4303

- Allows parent, spouse or legal guardian to give sent to health care. If there is no parent, spouse or legal guardian available, the next living relative may consent to medical procedures on the child's behalf.

## Testamentary Appointment of Guardian Minor

### Idaho Code Ann. § 39-15-5-202

- Allows parents to provide in their will for a guardian for their child. Guardian must accept this appointment with the court if the will is probated for the guardianship. A child over 14 may contest the process.

## Delegation of Powers by Parent or Guardian

### Idaho Code Ann. § 15-5-104

- Allows parent or guardian to delegate to another person the powers regarding care, including medical and educational care; this power may be delegated for no longer than 6 months (12 months for military personnel serving outside the United States).

## DeFacto Custodianship

### Idaho Code 15-5-207 and 15-5-213

- Court will recognize a de facto custodian who has resided with a child for 1 year (6 months if the child is under age 3) and has served as the primary caregiver and primary financial supporter of the child.
- Court will recognize a de facto custodian if it is in the best interests of the child.
- Idaho law provides that a de facto custodian has the same standing given to a parent in a guardianship action.
