In Kansas...

- There are 29,026 children living in grandparent-headed households (4.1% of all children in the state). There are another 8,739 children living in households headed by other relatives (1.2 % of all children in the state). Of the children living in households headed by grandparents or other relatives in Kansas, 16,184 are living there without either parent present.
- 17,873 grandparents report they are responsible for their grandchildren living with them [3,303 in Wichita and 2,210 in Kansas City]: 17% of these grandparents are African American; 11% are Hispanic/Latino; 2% are Asian; 2% are American Indian or Alaskan Native; and 67% are White. 38% of these grand-parents live in households without the children's parents present. 75.6% are under the age of 60; 13.2% live in poverty.

Children in Foster Care

State child welfare agencies sometimes place children in foster care with grandparents or other relatives. Most state agencies call these placements “kinship care.”

Numbers in foster care – August 2007

- 5,866 children in out-of-home placements under the supervision of the Kansas Department of Social and Rehabilitative Services (SRS).
- 1,493 of these children were placed with relatives.

Preferences

- State policy requires that kin be considered first for out-of-home placements.
- Kin may be allowed to care for a child informally but the home must be checked by a state agency which will conduct a walk through and background check of caregivers.
- Kin may be licensed as foster parent under same assessment procedures as non-kin foster parents.
- Licensed kin receive the same foster care payment as non-kin foster parents.
- State contracts with five private agencies to handle permanency placements of children in foster care system:
 - The Farm, Inc – Emporia
 - KVC Behavioral Health Care – Kansas City
 - Kansas Children’s Service League – Wichita
 - St Francis Academy – Salina
 - United Methodist Youthville – Newton

Public Benefits

Children are often eligible for state and federal benefits even if their caregivers do not have legal guardianship or custody. The following public benefits programs are offered in Kansas:

Financial Assistance

State Laws

Grandparents as Caregivers

- New program approved by legislature to provide financial assistance to eligible grandparents caring for grandchildren – see Grandparents as Caregivers under “Programs That Can Help”
- Started January 2007

Medical Consent (Kan. Stat. Ann § 38-136, 137)

- Allows parents to sign a consent form authorizing grandparent or relative caregiver to obtain immunization of child without obtaining legal custody or guardianship

Standby Guardianship (Kan. Stat. Ann. § 59-3036)

- Temporary, emergency guardianship if court finds there is a threat to the health or safety of the child
