### In Kentucky...

- 57,141 children live in grandparent-headed households (5.7% of all the children in the state). There are another 12,294 children living in households headed by other relatives (1.2% of all the children in the state). Of the children living in households headed by grandparents or other relatives in Kentucky, 30,241 are living there without either parent present.
- 35,818 grandparents report they are responsible for their grandchildren living with them 3,061 in Louisville and 1,946 in Lexington/Fayette): 15% of these grandparents are African American; 1% are Hispanic/Latino; 82% are White. 45% of these grandparents live in households without the children's parents present. 74% are under the age of 60; 22% live in poverty.

## Children in Foster Care

State child welfare agencies sometimes place children in foster care with grandparents or other relatives. Most state agencies call these placements “kinship care.”

## Numbers – November 2007

- 7,284 children in out-of-home placements under the supervision of the Kentucky Department for Community Based Services
- 8,600 children were placed with relatives (foster and kinship care programs in Kentucky are separate)

## Preferences

- State policy requires that kinship care be considered first when an out-of-home placement is sought for a child under the Department’s care.

## Kinship care licensing

- Kinship care providers are generally approved based on different standards than non-kin foster parents. Some may become licensed foster parents.
- Approved kinship caregivers receive a monthly payment through Temporary Assistance for Needy Families (TANF).

## Subsidized guardianship

- Subsidized guardianship is offered in Kentucky to kinship care providers willing to permanently care for children for whom reunification or adoption is not possible. It is considered an alternative to foster care.
- A child who has not been adjudicated abused or neglected is not eligible for the subsidized guardianship program in Kentucky unless both parents are deceased.

## Public Benefits

Children are often eligible for state and federal benefits even if their caregivers do not have legal guardianship or custody.

## State Laws

*Laws change and are subject to different interpretations. These general descriptions are not intended as legal advice in any particular situation.*

### De Facto Custodian

#### **Ky. Rev. Stat. Ann. § 403.270**

- Court may declare a relative or non-related caretaker as a child's custodian. The custodian must show that he/she has been primary caretaker and financial supporter of a child for six months or more (if the child is under 3) or one year if the child is older than 3 or has been placed by the Department for Community Based Services)

### Kentucky Caregiver Support Program

#### **910 Ky. Rev. Stat. Ann. § 1:260**

##### ***Contact information listed above***

- Established to assist grandparents of any age who are
  - the primary caregiver to a child 18 years of age or younger,
  - are Kentucky residents,
  - do not reside in the same home as the parents, and
  - meet certain income guidelines.
- Provides information, assistance in accessing services, counseling, support groups, training
- Financial assistance available up to \$750 per child for clothing, respite care, educational supplies, required legal services, mental or dental expenses, etc.

### KinCare Support Program

- Centralized statewide service program for grandparents caring for minor grandchildren to provide information and referrals through the Kentucky Resource Market toll-free number at 1-877-293-7447.
- Information available on such services as Kentucky Transitional Assistance Program, Medical coverage (including Kentucky Children's Health Insurance Program), educational services, child care, child support, support groups, housing assistance, legal services, respite care for low-income kinship caregivers.
