In Ohio...

- There are 157,298 children living in grandparent-headed households (5.4% of all children in the state). There are 35,333 children living in households headed by other relatives. Of the children living in households headed by grandparents or other relatives in Ohio, 76,794 are living there without either parent present.
- 86,009 grandparents report they are responsible for their grandchildren living with them (7,039 in Cleveland and 6,263 in Columbus): 27% of these grandparents are African American, 2% are Hispanic/Latino; and 68% are White. 40% of these grandparents live in households without the children's parents present. 73% are under the age of 60; 15% live in poverty.

Children in Foster Care

- Sometimes state child welfare agencies place children in foster care with grandparents or other relatives. This is often called “kinship care.”

Numbers – January 2006

- There were 17,112 children under the care of the Ohio Department of Job and Family Services, Bureau of Family Services in out of home placements. Of these, 3,000 children were placed with relatives.

Preferences and licensing

- State policy requires that kin be considered first when an out-of-home placement is sought for a child under the Department’s care.
- There is no separate licensing program for kinship foster parents.
- Kinship caregivers may choose to go through a less stringent approval process focused on basic health and safety criteria. These approved (but not licensed) caregivers receive support services with a lower cash benefit.

Subsidized Guardianship

Kinship Permanency Incentive Program

- Limited incentive payments to families caring for relative children who are judged by the court to have been abused, neglected, dependent or unruly.
- Caregivers who have been awarded legal custody or guardianship of a child on or after July 1, 2005 are eligible to apply
- Maximum award is \$3,500 over 2-1/2 years; these payments are in addition to TANF (Temporary Assistance for Needy Families) benefits for eligible families.
- To receive cash payments, eligible families must not earn more than 300% of federal poverty

guidelines, must apply through their county public children services agency, complete a family home study and criminal background check.

State Laws

The following state law may be helpful to grandparents and other relatives raising children¹:

Educational Consent

Oh. Rev. Code Ann. § 3313.64(11)

- Allows relatives raising children to exercise authority in school issues under certain circumstances.

Grandparent Power of Attorney and Caregiver Affidavit forms

Oh. Rev. Code Ann. § 3109.65 – 3109.73

- Creates legal documentation to assist grandparent caregivers who have physical custody of their grandchildren but have not been judicially awarded custody. These forms assist grandparents in enrolling grandchildren in school and accessing routine and emergency medical and dental care.
