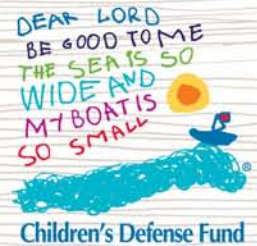

Health Coverage for All Children: Arizona

All Children Need Health Coverage that is Affordable, Comprehensive, and Simple.

Health Coverage for Arizona's Children:

- 269,000 children are uninsured (14.8% of all children). *
- 736,899 children are enrolled in Medicaid. **
- 39,589 children are enrolled in the Children's Health Insurance Program (CHIP). ***

How affordable is health coverage for Arizona's children? †

- CHIP eligibility is up to 200 percent of poverty (\$44,700 for a family of four).
- Medicaid eligibility is 140 percent of poverty (\$31,290) for children 0-1, 133 percent of poverty (\$29,327) for children 1-5, and 100 percent (\$22,350) for children 6-19.

How simple are enrollment procedures in CHIP and Medicaid for Arizona's children?

- Simplification procedures:
 - 12 month continuous eligibility for children in CHIP
 - No face-to-face interview
 - No asset test
 - Joint application
- Barriers that remain:
 - No 12-month continuous eligibility for children in Medicaid
 - No presumptive eligibility—which forces children to wait until their application is processed before they can see a doctor
 - No administrative verification of income—the state requires parents to provide proof of income before a child can get health coverage
 - 3 month waiting period

Do children in Arizona's CHIP program receive the same comprehensive benefits as children in Medicaid?

- Yes. Arizona provides children in its CHIP program the same comprehensive health and mental health coverage (through the Early and Periodic Screening Diagnostic and Treatment (EPSDT) benefit) that all children in Medicaid receive.
