Health Coverage for All Children: New Mexico

All Children Need Health Coverage that is Affordable, Comprehensive, and Simple.

Health Coverage for New Mexico's Children:

- 84,000 children are uninsured (15.5% of all children). *
- 323,448 children are enrolled in Medicaid. **
- 9,654 children are enrolled in the Children's Health Insurance Program (CHIP). ***

How affordable is health coverage for New Mexico's children? †

- Children's eligibility is up to 235 percent of poverty (\$52,523 for a family of four) through New Mexico's Medicaid expansion program (includes CHIP).

How simple are enrollment procedures in CHIP and Medicaid for New Mexico's children?

- Simplification procedures:
 - No face-to-face interview
 - No asset test
 - Presumptive eligibility for children in CHIP only—which allows children to see a doctor while their application is still being processed
 - 12-month continuous eligibility
 - Administrative verification of income at renewal—so parents do not have to provide proof of income for renewed enrollment.
- Barriers that remain:
 - 6 month waiting period
 - No administrative verification of income at enrollment—the state requires parents to provide proof of income before a child can get health coverage

Do children in New Mexico's CHIP program receive the same comprehensive benefits as children in Medicaid?

- Yes. New Mexico is one of 13 states (plus the District of Columbia) that has used CHIP funding to cover all children eligible for CHIP and Medicaid under one program. As a result, children in CHIP in these states receive the same comprehensive health and mental health coverage (through the Early and Periodic Screening Diagnostic and Treatment (EPSDT) benefit) that all children in Medicaid receive.
