

Children in the States 2019

ARIZONA



Child Population

- **1,633,490** children lived in Arizona in 2017.
- **61 percent** were children of color: 5 percent were Black; 44 percent were Hispanic; 3 percent were Asian/Native Hawaiian/Other Pacific Islander; and 5 percent were American Indian/Alaska Native.

Child Poverty

- **21 percent** of Arizona's children were poor in 2017—a total of **332,299** children—and children of color were disproportionately poor.
- **28 percent** of Black, **27 percent** of Hispanic and **11 percent** of White children were poor.
- **9 percent** of children were extremely poor (their family had income below half the poverty level).
- **23 percent** of children under 6 were poor.

Income and Wealth Inequality

- **\$85,600** was the median income for White families with children compared with **\$45,700** for Black and **\$42,900** for Hispanic families in 2017.

Housing and Homelessness

- **25,454** homeless children were enrolled in public schools during 2016-2017.
- **1.8 full-time jobs** at minimum wage were needed for a family to afford a two-bedroom rental unit at fair market rent in 2018.

Child Hunger and Nutrition

- **23 percent** of children lived in food-insecure households in 2016.
- **24 percent** of children ages 10-17 were overweight or obese in 2017.
- **26 percent** of children relied on the Supplemental Nutrition Assistance Program (SNAP) in FY2017.
- **90 percent** of children receiving free or reduced-price lunch during the 2016-2017 school year did not participate in Summer Nutrition Programs in 2017.

Child Health

- **133,144** children ages 0-18 (**8 percent**) were uninsured in 2017.
- **1,018,142** children ages 0-18 were enrolled in Arizona Healthcare Cost Containment System (Medicaid) and KidsCare (Children's Health Insurance Program) in FY2017.

Early Childhood

- **\$10,687** was the average annual cost for an infant in center-based child care in 2017.
- **4 percent** of 4-year-olds were enrolled in state-funded preschool during 2017-2018.

Education

- **80 percent** of Black, **82 percent** of Hispanic and **54 percent** of White 4th grade public school students could not read at grade level in 2017.
- **81 percent** of Black, **80 percent** of Hispanic and **57 percent** of White 8th grade public school students could not read at grade level in 2017.
- **76 percent** of Black, **76 percent** of Hispanic and **84 percent** of White students graduated high school on time during 2015-2016.
- **11 percent** of Black, **5 percent** of Hispanic and **4 percent** of White public secondary students had at least one out-of-school suspension in 2013-2014.

Child Welfare

- **9,909** children were abused or neglected in 2017.
- **15,031** children were in foster care on the last day of FY2017.

Juvenile Justice

- **717** children were in residential placement in 2015. **16 percent** were Black; **36 percent** were Hispanic; and **33 percent** were White.
- **76** children were in adult jails or prisons in 2016.

Gun Violence

- **77** children and teens were killed with guns in 2017.
