

Children in the States 2019

CONNECTICUT



Child Population

- **743,826** children lived in Connecticut in 2017.
- **45 percent** were children of color: 11 percent were Black; 24 percent were Hispanic; 5 percent were Asian/Native Hawaiian/Other Pacific Islander; and <1 percent were American Indian/Alaska Native.

Child Poverty

- **13 percent** of Connecticut's children were poor in 2017—a total of **92,583** children—and children of color were disproportionately poor.
- **20 percent** of Black, **26 percent** of Hispanic and **6 percent** of White children were poor.
- **6 percent** of children were extremely poor (their family had income below half the poverty level).
- **13 percent** of children under 6 were poor.

Income and Wealth Inequality

- **\$120,600** was the median income for White families with children compared with **\$49,900** for Black and **\$42,900** for Hispanic families in 2017.

Housing and Homelessness

- **4,293** homeless children were enrolled in public schools during 2016-2017.
- **2.5 full-time jobs** at minimum wage were needed for a family to afford a two-bedroom rental unit at fair market rent in 2018.

Child Hunger and Nutrition

- **16 percent** of children lived in food-insecure households in 2016.
- **21 percent** of children ages 10-17 were overweight or obese in 2017.
- **30 percent** of children relied on the Supplemental Nutrition Assistance Program (SNAP) in FY2017.
- **79 percent** of children receiving free or reduced-price lunch during the 2016-2017 school year did not participate in Summer Nutrition Programs in 2017.

Child Health

- **24,356** children ages 0-18 (**3 percent**) were uninsured in 2017.
- **377,969** children ages 0-18 were enrolled in HUSKY A (Medicaid) and HUSKY B (Children's Health Insurance Program) in FY2017.

Early Childhood

- **\$15,132** was the average annual cost for an infant in center-based child care in 2017.
- **30 percent** of 4-year-olds were enrolled in state-funded preschool during 2017-2018.

Education

- **77 percent** of Black, **75 percent** of Hispanic and **47 percent** of White 4th grade public school students could not read at grade level in 2017.
- **80 percent** of Black, **79 percent** of Hispanic and **45 percent** of White 8th grade public school students could not read at grade level in 2017.
- **79 percent** of Black, **76 percent** of Hispanic and **93 percent** of White students graduated high school on time during 2015-2016.
- **9 percent** of Black, **6 percent** of Hispanic and **2 percent** of White public secondary students had at least one out-of-school suspension in 2013-2014.

Child Welfare

- **8,442** children were abused or neglected in 2017.
- **4,135** children were in foster care on the last day of FY2017.

Juvenile Justice

- **141** children were in residential placement in 2015. **47 percent** were Black; **26 percent** were Hispanic; and **23 percent** were White.
- **63** children were in adult jails or prisons in 2016.

Gun Violence

- **14** children and teens were killed with guns in 2017.
