

Children in the States 2019

DISTRICT OF COLUMBIA



Child Population

- **124,492** children lived in D.C. in 2017.
- **77 percent** were children of color: 54 percent were Black; 17 percent were Hispanic; 2 percent were Asian/Native Hawaiian/Other Pacific Islander; and <1 percent were American Indian/Alaska Native.

Child Poverty

- **26 percent** of D.C.'s children were poor in 2017—a total of **31,618** children—and children of color were disproportionately poor.
- **40 percent** of Black, **13 percent** of Hispanic and **4 percent** of White children were poor.
- **14 percent** of children were extremely poor (their family had income below half the poverty level).
- **25 percent** of children under 6 were poor.

Income and Wealth Inequality

- **\$215,600** was the median income for White families with children compared with **\$30,600** for Black and **\$74,600** for Hispanic families in 2017.

Housing and Homelessness

- **6,415** homeless children were enrolled in public schools during 2016-2017.
- **2.6 full-time jobs** at minimum wage were needed for a family to afford a two-bedroom rental unit at fair market rent in 2018.

Child Hunger and Nutrition

- **22 percent** of children lived in food-insecure households in 2016.
- **36 percent** of children ages 10-17 were overweight or obese in 2017.
- **31 percent** of children relied on the Supplemental Nutrition Assistance Program (SNAP) in FY2017.
- **52 percent** of children receiving free or reduced-price lunch during the 2016-2017 school year did not participate in Summer Nutrition Programs in 2017.

Child Health

- **1,575** children ages 0-18 (**1 percent**) were uninsured in 2017.
- **97,580** children ages 0-18 were enrolled in Healthy Families (combined Medicaid and Children's Health Insurance Program) in FY2017.

Early Childhood

- **\$23,666** was the average annual cost for an infant in center-based child care in 2017.
- **85 percent** of 4-year-olds were enrolled in state-funded preschool during 2017-2018.

Education

- **79 percent** of Black, **78 percent** of Hispanic and **25 percent** of White 4th grade public school students could not read at grade level in 2017.
- **89 percent** of Black, **82 percent** of Hispanic and **23 percent** of White 8th grade public school students could not read at grade level in 2017.
- **68 percent** of Black, **69 percent** of Hispanic and **91 percent** of White students graduated high school on time during 2015-2016.
- **16 percent** of Black, **4 percent** of Hispanic and **1 percent** of White public secondary students had at least one out-of-school suspension in 2013-2014.

Child Welfare

- **1,639** children were abused or neglected in 2017.
- **751** children were in foster care on the last day of FY2017.

Juvenile Justice

- **105** children were in residential placement in 2015. **97 percent** were Black.
- **0** children were in adult jails or prisons in 2016.

Gun Violence

- **12** children and teens were killed with guns in 2017.
