

Children in the States 2019

ILLINOIS



Child Population

- **2,897,185** children lived in Illinois in 2017.
- **49 percent** were children of color: 15 percent were Black; 25 percent were Hispanic; 5 percent were Asian/Native Hawaiian/Other Pacific Islander; and <1 percent were American Indian/Alaska Native.

Child Poverty

- **17 percent** of Illinois's children were poor in 2017—a total of **486,196** children—and children of color were disproportionately poor.
- **38 percent** of Black, **20 percent** of Hispanic and **10 percent** of White children were poor.
- **8 percent** of children were extremely poor (their family had income below half the poverty level).
- **19 percent** of children under 6 were poor.

Income and Wealth Inequality

- **\$95,400** was the median income for White families with children compared with **\$34,500** for Black and **\$50,800** for Hispanic families in 2017.

Housing and Homelessness

- **51,617** homeless children were enrolled in public schools during 2016-2017.
- **2.5 full-time jobs** at minimum wage were needed for a family to afford a two-bedroom rental unit at fair market rent in 2018.

Child Hunger and Nutrition

- **16 percent** of children lived in food-insecure households in 2016.
- **34 percent** of children ages 10-17 were overweight or obese in 2017.
- **20 percent** of children relied on the Supplemental Nutrition Assistance Program (SNAP) in FY2017.
- **88 percent** of children receiving free or reduced-price lunch during the 2016-2017 school year did not participate in Summer Nutrition Programs in 2017.

Child Health

- **89,349** children ages 0-18 (**3 percent**) were uninsured in 2017.
- **1,760,638** children ages 0-18 were enrolled in Medical Assistance Program (Medicaid) and All Kids (Children's Health Insurance Program) in FY2017.

Early Childhood

- **\$13,474** was the average annual cost for an infant in center-based child care in 2017.
- **27 percent** of 4-year-olds were enrolled in state-funded preschool during 2017-2018.

Education

- **85 percent** of Black, **78 percent** of Hispanic and **53 percent** of White 4th grade public school students could not read at grade level in 2017.
- **85 percent** of Black, **75 percent** of Hispanic and **55 percent** of White 8th grade public school students could not read at grade level in 2017.
- **75 percent** of Black, **81 percent** of Hispanic and **90 percent** of White students graduated high school on time during 2015-2016.
- **22 percent** of Black, **5 percent** of Hispanic and **3 percent** of White public secondary students had at least one out-of-school suspension in 2013-2014.

Child Welfare

- **28,751** children were abused or neglected in 2017.
- **15,930** children were in foster care on the last day of FY2017.

Juvenile Justice

- **1,524** children were in residential placement in 2015. **63 percent** were Black; **14 percent** were Hispanic; and **21 percent** were White.
- **3** children were in adult jails or prisons in 2016.

Gun Violence

- **213** children and teens were killed with guns in 2017.
