

# Children in the States 2019

## INDIANA



### Child Population

- **1,573,409** children lived in Indiana in 2017.
- **29 percent** were children of color: 11 percent were Black; 11 percent were Hispanic; 2 percent were Asian/Native Hawaiian/Other Pacific Islander; and <1 percent were American Indian/Alaska Native.

### Child Poverty

- **18 percent** of Indiana's children were poor in 2017—a total of **282,390** children—and children of color were disproportionately poor.
- **40 percent** of Black, **28 percent** of Hispanic and **13 percent** of White children were poor.
- **8 percent** of children were extremely poor (their family had income below half the poverty level).
- **21 percent** of children under 6 were poor.

### Income and Wealth Inequality

- **\$74,900** was the median income for White families with children compared with **\$31,500** for Black and **\$44,300** for Hispanic families in 2017.

### Housing and Homelessness

- **18,431** homeless children were enrolled in public schools during 2016-2017.
- **2.1 full-time jobs** at minimum wage were needed for a family to afford a two-bedroom rental unit at fair market rent in 2018.

### Child Hunger and Nutrition

- **18 percent** of children lived in food-insecure households in 2016.
- **26 percent** of children ages 10-17 were overweight or obese in 2017.
- **22 percent** of children relied on the Supplemental Nutrition Assistance Program (SNAP) in FY2017.
- **81 percent** of children receiving free or reduced-price lunch during the 2016-2017 school year did not participate in Summer Nutrition Programs in 2017.

### Child Health

- **105,785** children ages 0-18 (**6 percent**) were uninsured in 2017.
- **818,687** children ages 0-18 were enrolled in Indiana Medicaid and Hoosier Healthwise (Children's Health Insurance Program) in FY2017.

### Early Childhood

- **\$12,312** was the average annual cost for an infant in center-based child care in 2017.

### Education

- **79 percent** of Black, **72 percent** of Hispanic and **54 percent** of White 4<sup>th</sup> grade public school students could not read at grade level in 2017.
- **81 percent** of Black, **66 percent** of Hispanic and **55 percent** of White 8<sup>th</sup> grade public school students could not read at grade level in 2017.
- **74 percent** of Black, **83 percent** of Hispanic and **90 percent** of White students graduated high school on time during 2015-2016.
- **20 percent** of Black, **6 percent** of Hispanic and **4 percent** of White public secondary students had at least one out-of-school suspension in 2013-2014.

### Child Welfare

- **29,198** children were abused or neglected in 2017.
- **20,904** children were in foster care on the last day of FY2017.

### Juvenile Justice

- **1,563** children were in residential placement in 2015. **36 percent** were Black; **7 percent** were Hispanic; and **53 percent** were White.
- **25** children were in adult jails or prisons in 2016.

### Gun Violence

- **102** children and teens were killed with guns in 2017.
