

# Children in the States 2019

## KANSAS



### Child Population

- **712,538** children lived in Kansas in 2017.
- **34 percent** were children of color: 6 percent were Black; 19 percent were Hispanic; 3 percent were Asian/Native Hawaiian/Other Pacific Islander; and <1 percent were American Indian/Alaska Native.

### Child Poverty

- **15 percent** of Kansas's children were poor in 2017—a total of **103,689** children—and children of color were disproportionately poor.
- **40 percent** of Black, **22 percent** of Hispanic and **10 percent** of White children were poor.
- **6 percent** of children were extremely poor (their family had income below half the poverty level).
- **17 percent** of children under 6 were poor.

### Income and Wealth Inequality

- **\$80,000** was the median income for White families with children compared with **\$37,400** for Black and **\$41,500** for Hispanic families in 2017.

### Housing and Homelessness

- **9,297** homeless children were enrolled in public schools during 2016-2017.
- **2.2 full-time jobs** at minimum wage were needed for a family to afford a two-bedroom rental unit at fair market rent in 2018.

### Child Hunger and Nutrition

- **18 percent** of children lived in food-insecure households in 2016.
- **32 percent** of children ages 10-17 were overweight or obese in 2017.
- **26 percent** of children relied on the Supplemental Nutrition Assistance Program (SNAP) in FY2017.
- **90 percent** of children receiving free or reduced-price lunch during the 2016-2017 school year did not participate in Summer Nutrition Programs in 2017.

### Child Health

- **39,476** children ages 0-18 (**5 percent**) were uninsured in 2017.
- **349,739** children ages 0-18 were enrolled in KanCare (Medicaid) and HealthWave (Children's Health Insurance Program) in FY2017.

### Early Childhood

- **\$10,955** was the average annual cost for an infant in center-based child care in 2017.
- **36 percent** of 4-year-olds were enrolled in state-funded preschool during 2017-2018.

### Education

- **83 percent** of Black, **72 percent** of Hispanic and **57 percent** of White 4<sup>th</sup> grade public school students could not read at grade level in 2017.
- **81 percent** of Black, **75 percent** of Hispanic and **58 percent** of White 8<sup>th</sup> grade public school students could not read at grade level in 2017.
- **77 percent** of Black, **79 percent** of Hispanic and **88 percent** of White students graduated high school on time during 2015-2016.
- **14 percent** of Black, **4 percent** of Hispanic and **3 percent** of White public secondary students had at least one out-of-school suspension in 2013-2014.

### Child Welfare

- **4,153** children were abused or neglected in 2017.
- **7,753** children were in foster care on the last day of FY2017.

### Juvenile Justice

- **564** children were in residential placement in 2015. **33 percent** were Black; **19 percent** were Hispanic; and **46 percent** were White.
- **0** children were in adult jails or prisons in 2016.

### Gun Violence

- **47** children and teens were killed with guns in 2017.
