

# Children in the States 2019

# MASSACHUSETTS



## Child Population

- **1,369,955** children lived in Massachusetts in 2017.
- **38 percent** were children of color: 9 percent were Black; 18 percent were Hispanic; 7 percent were Asian/Native Hawaiian/Other Pacific Islander; and <1 percent were American Indian/Alaska Native.

## Child Poverty

- **14 percent** of Massachusetts's children were poor in 2017—a total of **182,470** children—and children of color were disproportionately poor.
- **24 percent** of Black, **33 percent** of Hispanic and **6 percent** of White children were poor.
- **7 percent** of children were extremely poor (their family had income below half the poverty level).
- **15 percent** of children under 6 were poor.

## Income and Wealth Inequality

- **\$123,300** was the median income for White families with children compared with **\$50,100** for Black and **\$38,700** for Hispanic families in 2017.

## Housing and Homelessness

- **20,872** homeless children were enrolled in public schools during 2016-2017.
- **2.6 full-time jobs** at minimum wage were needed for a family to afford a two-bedroom rental unit at fair market rent in 2018.

## Child Hunger and Nutrition

- **12 percent** of children lived in food-insecure households in 2016.
- **26 percent** of children ages 10-17 were overweight or obese in 2017.
- **24 percent** of children relied on the Supplemental Nutrition Assistance Program (SNAP) in FY2017.
- **83 percent** of children receiving free or reduced-price lunch during the 2016-2017 school year did not participate in Summer Nutrition Programs in 2017.

## Child Health

- **21,885** children ages 0-18 (**2 percent**) were uninsured in 2017.
- **775,071** children ages 0-18 were enrolled in MassHealth, Massachusetts's Medicaid and Children's Health Insurance Programs in FY2017.

## Early Childhood

- **\$20,415** was the average annual cost for an infant in center-based child care in 2017.
- **30 percent** of 4-year-olds were enrolled in state-funded preschool during 2017-2018.

## Education

- **71 percent** of Black, **71 percent** of Hispanic and **40 percent** of White 4<sup>th</sup> grade public school students could not read at grade level in 2017.
- **74 percent** of Black, **72 percent** of Hispanic and **45 percent** of White 8<sup>th</sup> grade public school students could not read at grade level in 2017.
- **79 percent** of Black, **73 percent** of Hispanic and **92 percent** of White students graduated high school on time during 2015-2016.
- **10 percent** of Black, **8 percent** of Hispanic and **2 percent** of White public secondary students had at least one out-of-school suspension in 2013-2014.

## Child Welfare

- **25,092** children were abused or neglected in 2017.
- **10,919** children were in foster care on the last day of FY2017.

## Juvenile Justice

- **426** children were in residential placement in 2015. **30 percent** were Black; **41 percent** were Hispanic; and **23 percent** were White.
- **0** children were in adult jails or prisons in 2016.

## Gun Violence

- **29** children and teens were killed with guns in 2017.
