

Children in the States 2019

WEST VIRGINIA



Child Population

- **369,718** children lived in West Virginia in 2017.
- **11 percent** were children of color: 4 percent were Black; 3 percent were Hispanic; <1 percent were Asian/Native Hawaiian/Other Pacific Islander; and <1 percent were American Indian/Alaska Native.

Child Poverty

- **26 percent** of West Virginia's children were poor in 2017—a total of **93,758** children—and children of color were disproportionately poor.
- **52 percent** of Black, **31 percent** of Hispanic and **24 percent** of White children were poor.
- **12 percent** of children were extremely poor (their family had income below half the poverty level).
- **32 percent** of children under 6 were poor.

Income and Wealth Inequality

- **\$56,200** was the median income for White families with children compared with **\$22,400** for Black families in 2017.

Housing and Homelessness

- **9,024** homeless children were enrolled in public schools during 2016-2017.
- **1.6 full-time jobs** at minimum wage were needed for a family to afford a two-bedroom rental unit at fair market rent in 2018.

Child Hunger and Nutrition

- **20 percent** of children lived in food-insecure households in 2016.
- **35 percent** of children ages 10-17 were overweight or obese in 2017.
- **23 percent** of children relied on the Supplemental Nutrition Assistance Program (SNAP) in FY2017.
- **92 percent** of children receiving free or reduced-price lunch during the 2016-2017 school year did not participate in Summer Nutrition Programs in 2017.

Child Health

- **10,533** children ages 0-18 (**3 percent**) were uninsured in 2017.
- **283,189** children ages 0-18 were enrolled in Medicaid and the Children's Health Insurance Program in FY2017.

Early Childhood

- **\$8,528** was the average annual cost for an infant in center-based child care in 2017.
- **67 percent** of 4-year-olds were enrolled in state-funded preschool during 2017-2018.

Education

- **84 percent** of Black and **67 percent** of White 4th grade public school students could not read at grade level in 2017.
- **89 percent** of Black and **71 percent** of White 8th grade public school students could not read at grade level in 2017.
- **88 percent** of Black, **89 percent** of Hispanic and **90 percent** of White students graduated high school on time during 2015-2016.
- **13 percent** of Black, **4 percent** of Hispanic and **7 percent** of White public secondary students had at least one out-of-school suspension in 2013-2014.

Child Welfare

- **6,496** children were abused or neglected in 2017.
- **6,633** children were in foster care on the last day of FY2017.

Juvenile Justice

- **567** children were in residential placement in 2015. **8 percent** were Black; **2 percent** were Hispanic; and **84 percent** were White.
- **0** children were in adult jails or prisons in 2016.

Gun Violence

- **<10** children and teens were killed with guns in 2017.
