Child Population

- **2,857,266** children lived in Illinois in 2018.
- 49 percent were children of color: 15 percent were Black; 25 percent were Hispanic; 5 percent were Asian/Native Hawaiian/Other Pacific Islander; and <1 percent were American Indian/Alaska Native.

Child Poverty

- 16 percent of Illinois's children were poor in 2018– a total of 456,925 children–and children of color were disproportionately poor.
- 35 percent of Black, 20 percent of Hispanic and
 9 percent of white children were poor.
- 7 percent of children were extremely poor (their family had income below half the poverty level).
- 18 percent of children under 6 were poor.

Income and Wealth Inequality

 \$95,400 was the median income for white families with children compared with \$34,500 for Black and \$50,800 for Hispanic families in 2017.

Housing and Homelessness

- **51,617** homeless children were enrolled in public schools during 2016-2017.
- 2.5 full-time jobs at minimum wage were needed for a family to afford a two-bedroom rental unit at fair market rent in FY2019.

Child Hunger and Nutrition

- **16 percent** of children lived in food-insecure households in 2017.
- **34 percent** of children ages 10-17 were overweight or obese in 2017.
- 27 percent of children relied on the Supplemental Nutrition Assistance Program (SNAP) in FY2018.
- 89 percent of children receiving free or reducedprice lunch during the 2017-2018 school year did not participate in Summer Nutrition Programs in 2018.

Child Health

- 102,466 children ages 0-18 (3 percent) were uninsured in 2018.
- 1,356,850 children ages 0-18 were enrolled in Medical Assistance Program (Medicaid) and All Kids (Children's Health Insurance Program) in 2018.

Early Childhood

- \$13,762 was the average annual cost for an infant in center-based child care in 2018.
- **27 percent** of 4-year-olds were enrolled in state-funded preschool during 2017-2018.

Education

- 83 percent of Black, 77 percent of Hispanic and
 55 percent of white 4th grade public school students were not proficient in reading in 2019.
- 85 percent of Black, 75 percent of Hispanic and
 55 percent of white 8th grade public school students were not proficient in reading in 2019.
- 79 percent of Black, 84 percent of Hispanic and
 91 percent of white students graduated high school on time during 2016-2017.
- 22 percent of Black, 5 percent of Hispanic and 3 percent of white public school students had at least one out-of-school suspension in 2013-2014.

Child Welfare

- **31,515** children were abused or neglected in 2018.
- **16,840** children were in foster care on the last day of FY2018.

Youth Justice

- 1,071 children were in residential placement in 2017. 66 percent were Black; 11 percent were Hispanic; and 21 percent were white.
- **0** children were in adult prisons in 2017.

Gun Violence

 213 children and teens were killed with guns in 2017.
