

The State of America's Children® in MONTANA

2020 Factsheet



Child Population

- **229,434** children lived in Montana in 2018.
- **22 percent** were children of color: 1 percent were Black; 6 percent were Hispanic; <1 percent were Asian/Native Hawaiian/Other Pacific Islander; and 10 percent were American Indian/Alaska Native.

Child Poverty

- **16 percent** of Montana's children were poor in 2018—a total of **35,999** children—and children of color were disproportionately poor.
- **11 percent** of Hispanic and **13 percent** of white children were poor.
- **7 percent** of children were extremely poor (their family had income below half the poverty level).
- **18 percent** of children under 6 were poor.

Income and Wealth Inequality

- **\$73,100** was the median income for white families with children compared with **\$47,400** for Hispanic families in 2017.

Housing and Homelessness

- **3,606** homeless children were enrolled in public schools during 2016-2017.
- **1.9 full-time jobs** at minimum wage were needed for a family to afford a two-bedroom rental unit at fair market rent in FY2019.

Child Hunger and Nutrition

- **16 percent** of children lived in food-insecure households in 2017.
- **28 percent** of children ages 10-17 were overweight or obese in 2017.
- **19 percent** of children relied on the Supplemental Nutrition Assistance Program (SNAP) in FY2018.
- **82 percent** of children receiving free or reduced-price lunch during the 2017-2018 school year did not participate in Summer Nutrition Programs in 2018.

Child Health

- **14,917** children ages 0-18 (**6 percent**) were uninsured in 2018.
- **127,863** children ages 0-18 were enrolled in Montana Medicaid and Healthy Montana Kids (Children's Health Insurance Program) in 2018.

Early Childhood

- **2 percent** of 4-year-olds were enrolled in state-funded preschool during 2017-2018.

Education

- **74 percent** of Hispanic and **60 percent** of white 4th grade public school students were not proficient in reading in 2019.
- **75 percent** of Hispanic and **62 percent** of white 8th grade public school students were not proficient in reading in 2019.
- **81 percent** of Black, **80 percent** of Hispanic and **89 percent** of white students graduated high school on time during 2016-2017.
- **4 percent** of Black, **3 percent** of Hispanic and **3 percent** of white public school students had at least one out-of-school suspension in 2013-2014.

Child Welfare

- **3,763** children were abused or neglected in 2018.
- **3,946** children were in foster care on the last day of FY2018.

Youth Justice

- **183** children were in residential placement in 2017. **3 percent** were Black; **7 percent** were Hispanic; and **62 percent** were white.
- **0** children were in adult prisons in 2017.

Gun Violence

- **12** children and teens were killed with guns in 2017.
