

# The State of America's Children® in UTAH

## 2020 Factsheet



### Child Population

- **932,462** children lived in Utah in 2018.
- **27 percent** were children of color: 1 percent were Black; 18 percent were Hispanic; 3 percent were Asian/Native Hawaiian/Other Pacific Islander; and <1 percent were American Indian/Alaska Native.

### Child Poverty

- **10 percent** of Utah's children were poor in 2018—a total of **87,445** children—and children of color were disproportionately poor.
- **25 percent** of Black, **19 percent** of Hispanic and **7 percent** of white children were poor.
- **4 percent** of children were extremely poor (their family had income below half the poverty level).
- **10 percent** of children under 6 were poor.

### Income and Wealth Inequality

- **\$85,700** was the median income for white families with children compared with **\$59,900** for Black and **\$46,300** for Hispanic families in 2017.

### Housing and Homelessness

- **15,438** homeless children were enrolled in public schools during 2016-2017.
- **2.5 full-time jobs** at minimum wage were needed for a family to afford a two-bedroom rental unit at fair market rent in FY2019.

### Child Hunger and Nutrition

- **15 percent** of children lived in food-insecure households in 2017.
- **26 percent** of children ages 10-17 were overweight or obese in 2017.
- **10 percent** of children relied on the Supplemental Nutrition Assistance Program (SNAP) in FY2018.
- **84 percent** of children receiving free or reduced-price lunch during the 2017-2018 school year did not participate in Summer Nutrition Programs in 2018.

### Child Health

- **72,258** children ages 0-18 (**7 percent**) were uninsured in 2018.
- **195,061** children ages 0-18 were enrolled in Medicaid and the Children's Health Insurance Program in 2018.

### Early Childhood

- **\$10,002** was the average annual cost for an infant in center-based child care in 2018.

### Education

- **80 percent** of Hispanic and **54 percent** of white 4<sup>th</sup> grade public school students were not proficient in reading in 2019.
- **79 percent** of Hispanic and **57 percent** of white 8<sup>th</sup> grade public school students were not proficient in reading in 2019.
- **73 percent** of Black, **77 percent** of Hispanic and **88 percent** of white students graduated high school on time during 2016-2017.
- **4 percent** of Black, **3 percent** of Hispanic and **1 percent** of white public school students had at least one out-of-school suspension in 2013-2014.

### Child Welfare

- **10,122** children were abused or neglected in 2018.
- **2,611** children were in foster care on the last day of FY2018.

### Youth Justice

- **222** children were in residential placement in 2017. **7 percent** were Black; **39 percent** were Hispanic; and **49 percent** were white.
- **1** child was in an adult prison in 2017.

### Gun Violence

- **46** children and teens were killed with guns in 2017.
