

The State of America's Children® in **VERMONT** 2020 Factsheet



Child Population

- **115,973** children lived in Vermont in 2018.
- **11 percent** were children of color: 2 percent were Black; 3 percent were Hispanic; 2 percent were Asian/Native Hawaiian/Other Pacific Islander; and <1 percent were American Indian/Alaska Native.

Child Poverty

- **12 percent** of Vermont's children were poor in 2018—a total of **13,712** children—and children of color were disproportionately poor.
- **27 percent** of Hispanic and **12 percent** of white children were poor.
- **6 percent** of children were extremely poor (their family had income below half the poverty level).
- **11 percent** of children under 6 were poor.

Income and Wealth Inequality

- **\$69,700** was the median income for white families with children in 2017.

Housing and Homelessness

- **1,097** homeless children were enrolled in public schools during 2016-2017.
- **2.1 full-time jobs** at minimum wage were needed for a family to afford a two-bedroom rental unit at fair market rent in FY2019.

Child Hunger and Nutrition

- **16 percent** of children lived in food-insecure households in 2017.
- **33 percent** of children ages 10-17 were overweight or obese in 2017.
- **20 percent** of children relied on the Supplemental Nutrition Assistance Program (SNAP) in FY2018.
- **71 percent** of children receiving free or reduced-price lunch during the 2017-2018 school year did not participate in Summer Nutrition Programs in 2018.

Child Health

- **2,463** children ages 0-18 (**2 percent**) were uninsured in 2018.
- **63,270** children ages 0-18 were enrolled in Dr Dynasaur (combined Medicaid and Children's Health Insurance Program) in 2018.

Early Childhood

- **\$12,507** was the average annual cost for an infant in center-based child care in 2018.
- **76 percent** of 4-year-olds were enrolled in state-funded preschool during 2017-2018.

Education

- **63 percent** of white 4th grade public school students were not proficient in reading in 2019.
- **59 percent** of white 8th grade public school students were not proficient in reading in 2019.
- **77 percent** of Black, **90 percent** of Hispanic and **90 percent** of white students graduated high school on time during 2016-2017.
- **7 percent** of Black, **4 percent** of Hispanic and **4 percent** of white public school students had at least one out-of-school suspension in 2013-2014.

Child Welfare

- **958** children were abused or neglected in 2018.
- **1,308** children were in foster care on the last day of FY2018.

Youth Justice

- **18** children were in residential placement in 2017. **17 percent** were Black; **0 percent** were Hispanic; and **83 percent** were white.
- **2** children were in adult prisons in 2017.

Gun Violence

- **<10** children and teens were killed with guns in 2017.
