

The State of America's Children® in IOWA

2021 Factsheet



Child Population

- **726,841** children lived in Iowa in 2019.
- **23 percent** were children of color: 5 percent were Black; 10 percent were Hispanic; 3 percent were Asian/Native Hawaiian/Other Pacific Islander; and <1 percent were American Indian/Alaska Native.

Child Poverty

- **13 percent** of Iowa's children were poor in 2019—a total of **92,018** children—and children of color were disproportionately poor.
- **38 percent** of Black, **22 percent** of Hispanic and **10 percent** of white children were poor.
- **5 percent** of children were extremely poor (their family had income below half the poverty level).
- **15 percent** of children under 6 were poor.

Income and Wealth Inequality

- **\$86,400** was the median income for white families with children compared with **\$36,900** for Black and **\$48,600** for Hispanic families in 2019.

Housing and Homelessness

- **7,124** unhoused children were enrolled in public schools during 2017-2018.
- **2.1 full-time jobs** at minimum wage were needed for a family to afford a two-bedroom rental unit at fair market rent in FY2020.

Child Hunger and Nutrition

- **14 percent** of children lived in food-insecure households in 2018.
- **20 percent** of children relied on the Supplemental Nutrition Assistance Program (SNAP) in FY2018.
- **90 percent** of children receiving free or reduced-price lunch during the 2018-2019 school year did not participate in Summer Nutrition Programs in 2019.

Child Health

- **22,351** children ages 0-18 (**3 percent**) were uninsured in 2019.
- **338,908** children ages 0-18 were enrolled in Iowa Medicaid Enterprise (Medicaid) and Hawk-I (Children's Health Insurance Program) in 2019.

Early Childhood

- **\$11,185** was the average annual cost for an infant in center-based child care in 2019.
- **66 percent** of 4-year-olds were enrolled in state-funded preschool during 2018-2019.

Education

- **89 percent** of Black, **80 percent** of Hispanic and **60 percent** of white 4th grade public school students were not proficient in reading in 2019.
- **87 percent** of Black, **81 percent** of Hispanic and **64 percent** of white 8th grade public school students were not proficient in reading in 2019.
- **81 percent** of Black, **84 percent** of Hispanic and **93 percent** of white students graduated high school on time during 2017-2018.
- **11 percent** of Black, **3 percent** of Hispanic and **2 percent** of white public secondary students had at least one out-of-school suspension in 2015-2016.

Child Welfare

- **11,648** children were abused or neglected in 2019.
- **5,955** children were in foster care on the last day of FY2019.

Youth Justice

- **585** children were in residential placement in 2017. **35 percent** were Black; **10 percent** were Hispanic; and **46 percent** were white.
- **0** children were in adult jails or prisons in 2019.

Gun Violence

- **26** children and teens were killed with guns in 2019.
