

The State of America's Children® in OHIO

2021 Factsheet



Child Population

- **2,578,019** children lived in Ohio in 2019.
- **29 percent** were children of color: 15 percent were Black; 6 percent were Hispanic; 3 percent were Asian/Native Hawaiian/Other Pacific Islander; and <1 percent were American Indian/Alaska Native.

Child Poverty

- **18 percent** of Ohio's children were poor in 2019—a total of **466,168** children—and children of color were disproportionately poor.
- **39 percent** of Black, **30 percent** of Hispanic and **13 percent** of white children were poor.
- **8 percent** of children were extremely poor (their family had income below half the poverty level).
- **21 percent** of children under 6 were poor.

Income and Wealth Inequality

- **\$81,700** was the median income for white families with children compared with **\$33,300** for Black and **\$45,800** for Hispanic families in 2019.

Housing and Homelessness

- **34,180** unhoused children were enrolled in public schools during 2017-2018.
- **1.8 full-time jobs** at minimum wage were needed for a family to afford a two-bedroom rental unit at fair market rent in FY2020.

Child Hunger and Nutrition

- **19 percent** of children lived in food-insecure households in 2018.
- **22 percent** of children relied on the Supplemental Nutrition Assistance Program (SNAP) in FY2018.
- **90 percent** of children receiving free or reduced-price lunch during the 2018-2019 school year did not participate in Summer Nutrition Programs in 2019.

Child Health

- **131,029** children ages 0-18 (**5 percent**) were uninsured in 2019.
- **1,174,978** children ages 0-18 were enrolled in HealthyStart (combined Medicaid and Children's Health Insurance Program) in 2019.

Early Childhood

- **\$9,919** was the average annual cost for an infant in center-based child care in 2019.
- **11 percent** of 4-year-olds were enrolled in state-funded preschool during 2018-2019.

Education

- **85 percent** of Black, **78 percent** of Hispanic and **58 percent** of white 4th grade public school students were not proficient in reading in 2019.
- **88 percent** of Black, **70 percent** of Hispanic and **55 percent** of white 8th grade public school students were not proficient in reading in 2019.
- **69 percent** of Black, **73 percent** of Hispanic and **86 percent** of white students graduated high school on time during 2017-2018.
- **19 percent** of Black, **7 percent** of Hispanic and **4 percent** of white public secondary students had at least one out-of-school suspension in 2015-2016.

Child Welfare

- **25,470** children were abused or neglected in 2019.
- **16,387** children were in foster care on the last day of FY2019.

Youth Justice

- **2,079** children were in residential placement in 2017. **49 percent** were Black; **3 percent** were Hispanic; and **41 percent** were white.
- **36** children were in adult jails or prisons in 2019.

Gun Violence

- **142** children and teens were killed with guns in 2019.
