## **Book Bans Across the Nation**

- In the first half of the 2022-2023 school year alone, there were 1,477 book challenges against 874 unique titles across the country.
- Challenged books often include themes of abuse, health and wellbeing, grief and death, race/racism, and LGBTQ+ stories.
- Bans have been codified in several states in 2022-23
  - **Texas:** Book sellers must rate books
  - Florida: Prohibiting instruction regarding sexual orientation in K-3rd grade and creating a system to monitor instructional materials.
  - **Utah:** Prohibiting sensitive or pornographic instructional materials in schools.
  - Similar laws have been passed in Georgia, Tennessee, and Missouri.

# HB 900: The Next Stage of Book Banning

- This year, TX passed House Bill 900, which has been called "model legislation" by book banners to escalate bans.
- HB 900 will:
  - Force third-party vendors from Amazon to local bookstores to rate books based on vague standards like "educationally unsuitable" and "sexually relevant";
  - Give the Texas Education Agency overarching power to ultimately ban books based on their own determination and with no public accountability;
  - Require schools to review their entire collection for "sexually relevant" materials; and
  - Create a surveillance system where parents have to consent before students can check out any books rated as "sexually relevant."
- The bill has already been used as an excuse in Katy ISD to pause all new library purchases.



# **Common Language of Book Banning**

- **Parental Rights Language:** Used both in Florida and Texas law. Often used to frame laws in terms of empowering parents to be involved in their schools.
- **Explicit or Obscene Material:** Argument for bills revolves around keeping students from explicit or pornographic material. In reality, the scenes in literature referred to as sexually explicit are not considered in the context of the book as a whole.
- **"According to state law":** This is was originally used in order to evoke Texas' obscenity laws. It is now also being used to invoke HB 900. It's wrong in both cases.

- To put it bluntly, this is a movement led by white christian nationalists. Some are even self proclaimed.
- When they say Parental Rights, they are saying that their rights override everyone else's.
- When they speak about protecting children, they're speaking about a very specific group of children.



# **Common Tactics: Infiltrate and Takeover**



# The main strategy is initiating a take over of school boards.

This is usually done by taking advantage of the low voter turnout in most local elections and running candidates that are pro censorship and book banning. This is paired with misinformation and fear mongering. (This has happened in Keller, Mansfield, Grapevine-Colleyville, etc.)

- Look for the appearance of new organizations or PACs, a large increase in campaigning, and a dramatic increase in funding.
  - Patriot Mobile, Mom's for Liberty, etc.





# What it Looks Like: Keller ISD

Keller ISD, is located near the Dallas-Fort Worth area, and has been all but completely taken over the school board, with there now being only one dissenting voice.

They've been the target of Patriot Mobile, a christian nationalist cell phone company that has been heavily investing in school races. They have also joined Keller's Chamber of Commerce.

Misinformation, like creating organizations that don't exist in order to appeal to voters, fake mailers, and even allowing partisan groups like the Keller Republicans to not only hold the school board candidate town hall, but also restrict access to certain community members.



# **Common Tactics: Silence and Sabotage**



In order to put policies in place, these newly acquired boards will make feedback and participation difficult for those that oppose them.

This can be done by changing the way school board meetings operate. Forms of this include:

- Making it more difficult for people to speak at meetings by eliminating paper sign up the day of the meeting, moving sign up online, and requiring sign ups be done hours in advance of speaking.
- Structuring meetings in a way that makes it difficult for people to stay the entire time, like moving public comment to the very end of an hours long meeting.



# What it Looks Like: Mansfield ISD

Mansfield ISD, located in the Dallas-Fort Worth Metroplex and encompassing parts of Arlington, has emulated Keller's tactics down to the literal letter, with the verbiage of their policies being almost identical.

They've also initiated a switch to online registration for public comment, but Mansfield stands out in their way of silencing public comment.

They appear to be trying to outlast those in the community that arrive to speak against certain policies, by moving public comment late into the meeting.

# Policy Proposed in Mansfield ISD cont.



### Steps of Acquisition Procedures:

- Library materials are recommended and gathered by the Superintendent designee(s).
- 2. Library materials list submitted to the Superintendent.
- Library materials list is posted on district website for public review at the regular Board meeting for 1<sup>st</sup> Reading.
- 4. Feedback may be given by the public during a 10-day period that starts the day of the regular Board meeting for 1<sup>st</sup> Reading.
- Feedback will be compiled and placed on district website and given to the Board, 72 hours prior to the next regularly scheduled Board meeting.
- Library material lists materials are submitted at the next regular Board meeting as Consent Item for 2<sup>nd</sup> Review.
- 7. Items approved by the Board at 2<sup>nd</sup> Review may be purchased.

The District-level library supervisor(s), designated administrator and librarians shall select material based on their own expertise in accordance with EFB(Exhibit).

# The Cost of Book Bans

Texas lawmakers ended this year's regular legislative session without giving public schools any money for employee raises, many districts are facing a budget deficit, yet when it comes to banning books, money seems to be no object.

For example, in Keller ISD: Honors classes on some campuses have been cut or lumped into general honors classes on several campuses A program for pregnant teens has been cut, Intervention counselors have been cut and reassigned, and early intervention programs, like "TALK", for children with speech delays has also been cut.

From read-ins in Mansfield to showing out in the public comment section of the school board meetings in Keller, Texans aren't going quietly into the night, and we at CDF-TX are working on supporting their efforts.

We are working with groups in multiple school districts, in cities and suburbs across the state to support these communities and the emerging organizations that are fighting back.



# What it Looks Like: Mansfield ISD



News first broke out that Mansfield was trying to institute a policy similar to Keller, the very same day they announced a special meeting to introduce the policy.

With little to no time to prepare, upwards of forty people showed up to speak against it, with only two in favor.

Now with a newly elected school board member, read-ins, and collaboration that encompasses other districts, educators, and the faith community, the people of Mansfield have proven that they're going to keep showing up.



\*Interesting tactic: Because the board tried to insist that librarians were in favor of the new policy, some Mansfield residents conducted an unofficial survey and contacted all of the district librarians. Of the forty-four contacted, forty-two were against it, the remaining two didn't respond.

# What it Looks Like: Keller ISD

OR

Keller ISD Families for Public Education is a collective of parents that have not missed a single meeting since the book ban battle began.

When the attacks on books and education grew more intense and sophisticated, so did they, turning to FOIA requests, talking to news outlets, and even starting to form their own nonprofit to entrench their resistance in Keller.

They were able to increase voter turnout by a thousand votes and plan to do even better by the next election.

Keller is a hard place to win in, with the board just passing a policy that opens the door for gender discrimination and the mistreatment of queer youth, but the resistance in Keller is one thing above all else: Resilient.



\*Interesting tactic: When Patriot Mobile joined the Keller Chamber of Commerce, so did Keller ISD Families for Public Education. When they were banned from where some of the boards were holding a town hall, they held their own forum to meet the candidates.

# **Teachers: Freedom of Speech**

- Free Speech is protected for teachers, even when you identify yourself as a school employee.
- Generally safer to avoid speaking about specific job duties, instead talk about general concerns regarding your topic.
- Students Rights: Students are free to organize and protest, though districts can limit when, where, and how protests occur.
